TERMS & CONDITIONS OF PURCHASE

- Quality: The goods against this order should conform to the standards & specifications in all respects, as stipulated including make, description 8 workmanship. If samples, patterns drawings etc. are provided by us, the goods shall be in all respects, in accordance with the same.
- 2. **Packing Material:** In case of order for Printed packing material: after finalization of Artwork supplier should send three folders of final color printouts each folder containing three shades Light, Medium and Dark, mentioning all specifications i.e. Board, dimensions, color code, size & send for our approval. The goods shall be in all respects, in accordance with the same.
- 3. **Quantity:** The quantities of goods received at our premises are subject to inspection and checked as per the weights and measurements at our factory premises and will be taken as final. Goods supplied in excess of the ordered units may not be paid for. In case of Printed Packing Material only excess up to 3% of the ordered units will be accepted. The goods supplied in excess of this will not be paid for and either will be destroyed or will remain in the Excess Material Supplied Section in Stores as supplier's property and not a part of inventory. Till he supply is regularized, it will be supplier's risk and cost.
- 4. **Packing:** Goods must be securely packed to withstand normal hazards in transit upto destination and prices mentioned are inclusive of packing charges unless otherwise specifically mentioned in the order. All the packages under this order must clearly show gross weight, tare weight, net weight and Sr. no. & Label Text as per FDA requirement Schedule 'U'
- 5. **Delivery:** Delivery is the essence of the contract.
